MINUTE ENTRY

SENTENCE OF PROBATION

Defendant present, out of custody.

The defendant is advised of the charge and the determination of guilt, and all parties are given the opportunity to make recommendations/statements to the Court.

Pursuant to A.R.S. § 13-607, the Court finds as follows:

WAIYER OF TRIAL--The defendant knowingly, intelligently, and voluntarily waived his right to a trial with or without a jury, his right to confront and cross-examine witnesses, his right to testify or remain silent, his right to present evidence and call his own witnesses, and his right to review after having been advised of these rights. The determination of guilt was based upon a plea of guilty.

Upon due consideration of the offense, and the facts, law and circumstances involved in this case, and having found no legal cause to delay rendition of judgment and pronouncement of sentence, the Court enters the following judgment and sentence:

IT IS THE JUDGMENT OF THE COURT that the defendant is guilty of AMENDED COUNT ONE: AGGRAVATED ASSAULT ON AN INCAPACITATED VICTIM, a Class Six Undesignated Offense, nondangerous, nonrepetitive offense, in violation of A.R.S. § 13-1204(A)(4) committed on June 01, 2017 through July 31, 2017.

THE COURT FINDS that the defendant is eligible for probation. The specific reasons for the granting of probation are stated by the Court on the record.

MINUTE ENTRY

IT IS ORDERED suspending imposition of sentence and placing the defendant on probation for a period of EIGHTEEN (18) MONTHS, commencing on June 05, 2018, under the supervision of the Adult Probation Department of this Court, in accordance with the formal Judgment and Order signed by the Court suspending sentence and imposing terms of probation.

IT IS ORDERED that the defendant complete ONE HUNDRED (100) hours of approved community restitution as directed.

IT IS ORDERED that the defendant be placed on the Sex Offender Caseload.

IT IS ORDERED that the defendant abide by all conditions of probation as set forth in the Uniform Conditions of Supervised Probation.

IT IS ORDERED that the defendant shall report to the Adult Probation Department no later than 5:00 PM, this date.

IT IS ORDERED that the Adult Probation Department has the discretion to permit the defendant to complete counseling with Dr. Goldman in lieu of participating in group classes.

IT IS FURTHER ORDERED that the defendant shall pay the following:

1. Time Payment Fee in the amount of \$20.00.
2. Attorney's Fees in the amount of \$400.00 are waived as counsel was retained.
3. Monthly Probation Services Fee at the rate of \$65.00.
4. Probation Assessment in the amount of \$20.00.
5. Surcharge Assessment in the amount of \$13.00.
6. Victim Rights Enforcement Fund Fee in the amount of \$2.00.

The written terms and conditions of probation are handed to the defendant for explanation, acceptance, and signature. The defendant is advised concerning the consequences of failure to abide by the conditions of probation.

IT IS ORDERED that any outstanding bond that has not been previously referred for a bond forfeiture proceeding is hereby exonerated.

IT IS ORDERED, pursuant to the plea, that all remaining counts and allegations shall be dismissed as to this cause number only.

The defendant is advised of his Rights of Review, signs, and receives a copy of same.
